After the completed application is returned to the OFDA offices, it will be submitted to the OFDA Board of Directors together with a report of the Membership Committee and report from a District President in the District where the applicant resides. (If the applicant is a funeral director licensed in a state other than Ohio, the report of the District President will not be required). An applicant must receive an affirmative vote of two-thirds of the members of the OFDA Board of Directors in order to be admitted into membership.
- 2. <u>Application</u>. To complete the application, please fill in all of the information on the reverse side. An application will only be considered if it is filled out completely and lists the names of two Ohio funeral directors willing to submit letters of recommendation for the applicant for Associate Membership.
